#### Ongoing Initiative With 2 Broad Categories

- Continuing education
  - Current providers of behavioral health related services
- Preparatory education
  - Individuals interested in working within behavioral health at all levels

#### PLAN Objectives/Activities

Original Plan-6 Objectives

- 8 long term activities (3 years+)
- 23 short term activities (1–2 years)

DISCLAIMER: The items addressed in this presentation are updates related to the original plan.

## Objective

- Increase access to training resources related to behavioral healthcare; main focus on Alcohol and other Drug (AOD) related topics; provide access to training in models of integrated behavioral and physical health care
- Target current workforce

#### Delaware Learning Center

- Electronic repository (listing) of behavioral health related workshops implemented January 2016
- Available to all State employees
- Available through the DSAMH portal for ALL external users
  - Most in-person workshops are at no cost
  - Almost all workshops offer continuing education
  - There is a nominal \$2.50 per person registration/transaction fee that is charged by the software company

#### Increase Access to Training

- Partnered with Central East Addiction Technology Transfer Center (CE-ATTC) to bring addiction training to Delaware programs.
  - Held in December 2015 for over 500 participants at no cost to participants
  - Additional training being planned for 2016

#### Increase Access to Training

- Create other series for mental health professionals that address skills and knowledge based training in common core subject areas in the field of mental health
  - Over 100 no cost behavioral health training workshops currently available to Delaware professionals through the new Delaware Learning Center
  - Multiple conferences on mental health and substance use planned for fall 2016

## Increase Access to Training Cont'd.

- Partnered with Autism Delaware to provide no cost conference on Improving Outcomes for Adults with Autism Spectrum Disorders and Mental Health Diagnoses in March 2016 for over 200 participants
- April no cost conference on Substance Use and Medical issues
- Division of Public Health and Division of Substance Abuse and Mental Health have planned a June 6<sup>th</sup> no cost conference on tobacco cessation among the population who also have mental health diagnoses
- Expansion of video conferencing workshops to reach upstate and downstate audiences – currently offered monthly

#### Health Education

#### DE Division of Public Health

- Currently using Smart Moves-Smart Choices curriculum for prescription drug abuse education.
- ➤ Exploring a grades 3–12 evidence-based curriculum in reducing opioid abuse using a life skills approach.

## New Programs to meet the community needs Cont'd.

- 4 new certificates (Wilmington University)
- 1. Holistic Palliative and End of Life Care
- 2. Nutrition and Fitness
- 3. Health & Wellness
  - All 3 will be available to students, either post HS graduation or as a continuation of an AP course completed while in HS.
  - 15-16 college credits upon completion of each certificate which could be applied to a future BS degree.
- 4. Trauma-Informed Approaches a 15 credit undergraduate certificate available to both undergraduate students and professionals working in the field.

## New Programs to meet the community needs Cont'd.

- Beginning Summer 2016 Wilmington University will offer
  - 3 new courses in Trauma-Informed Approaches,
  - 2 new courses related to Palliative and End-of Life Care,
  - 4 new courses related to Nutrition, Wellness and Exercise

#### **Proposed Certificates**

- Wilmington University is working on a Public Health Certificate
  - Population: undergraduate students
  - Content:
    - general education in public and population health
    - epidemiology
    - health policy

## Objective

- Influence graduate schools curriculum to reflect SHIP initiatives and current needs based on data
- Target current and future workforce

#### **Proposed Certificate**

- Wilmington University is also working on a Post-Graduate Psychiatric Mental Health Nurse Practitioner Certificate
  - Upon completion, the student would be eligible to apply for National Board Certification.
